### 1. Consent to participate in risk-related activity

I hereby declare that my daughter/son is in **good health** and, in particular, not affected by any of the following health conditions which exclude her/him from participating: Eye surgery / Hypertension / Chronic diseases of the ear with balance disorders / Heart problems / Epilepsy / Increased cardiovascular risk / Neurological problems / Whiplash / Pregnancy. She/he meets the requirements to participate in the activity; in particular, there are no obstacles related to her/his person or health. Persons who are particularly at risk according to the FOPH (BAG) with regard to the Covid 19 virus (coronavirus) are advised not to participate on any of our trips. In case of symptoms or signs of a Covid 19 disease according to the FOPH (BAG), participation in all activities must be refrained from.

Furthermore, I declare that my daughter/son is of full **mental capacity** and not under the influence of **drugs (light or hard), alcohol, psychotropic drugs or other medicines** that could degrade her/his consciousness.

I am aware that the activity may affect the health of my daughter/son and that she/he may withdraw from it at any time. Furthermore I pledge that she/he will act according to the instructions of Outdoor Interlaken AG (hereinafter the Organiser), which reserves the right to cancel the activity/tour at any time.

I **waive all rights of action or recourse** with regard to any damage or accidents suffered in connection with the event, in particular contractual and tort claims against the Organiser, unless the accident or damage is due to intent or gross negligence on the part of the Organiser. The Organiser hereby accepts this waiver. The Organiser rejects any liability for damage to any objects carried such as cameras, mobile phones, glasses, sunglasses, etc.

I am aware that my daughter/son is not insured by the Organiser.

Should one of these provisions be ineffective, this shall not result in the ineffectiveness of the entire Agreement, unless it can be assumed that the Agreement would not have been concluded at all without the ineffective provision.

### 2. Consent to the use of images (online and print)

I hereby declare that the Organiser may **record and use images** (videos/short films/commercials/photos) of my daughter/son, using her/his first name and surname.

This means that I agree to the Organiser using the images recorded in any of their **communications and especially for marketing and educational purposes** and **publishing** them on their **platforms** (especially social media channels, in particular Instagram, YouTube, Facebook, Twitter, Google+; websites, outdoor-interlaken.ch; in print and digital media, as a live stream) (even multiple times) **free of charge**.

This consent is valid for an unlimited period of time, but may be revoked in writing at any time, with future effect. In the event of revocation, the recordings will be deleted from the respective platform/channel. If the images are available on the Internet, they will be deleted provided that such deletion can be carried out by Outdoor Interlaken AG. The copyright of the resulting images belong to the Organiser (in particular, no right to remuneration). It guarantees that it will handle the images responsibly and respectfully.
